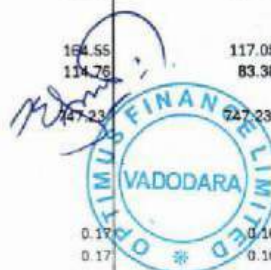

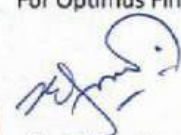

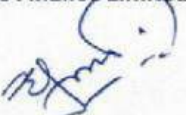

Opinion

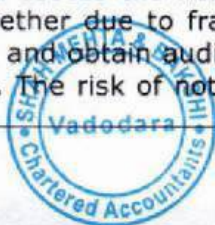

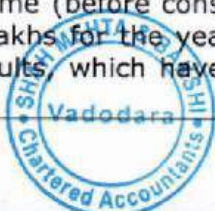
